#### **OTHER STRUCTURES**

Agent provides full service on international tax planning, corporate structuring, estate and trust planning and other fiduciary services. These include companies (such as GBC1 or GBC2), Mauritius Fund, etc. The GBC1 enables you to benefit from the double taxation treaty agreements which Mauritius has ratified with 35 countries. The GBC2 is the classical IBC and has similar characteristics. Please contact for an exploratory explanation to know more on our services, corporate structures and our pricing.

#### **NOTES:**

- I. Fees may vary depending on exposure, level of activity/technical complexity. ANNUAL FEES (item 3 & 4 above) apply only where assets under management do not exceed USD 500,000 or its equivalent in other currencies. There is an additional fee of 0.1% per annum for any excess amount of assets. Secondly the ANNUAL FEES do not include professional, administrative nor secretarial services. These are charged and invoiced independently and in addition to the ANNUAL FEES.
- II. FSC license fees run from 1st July to 30 June next year rather than annual anniversary date of incorporation. The license of this company will run from date of approval to next June. The FSC fees are pro-rated in four quarters of the year and relevant pro-rated fee will apply depending in which quarter this application is being made.
- III. Courier fees and bank charges and other disbursements are billed separately and charged at cost.
- IV. We charge on a time and cost basis for services provided other than listed above. This is available on request.
- V. Agent reserves the right to amend this fee agreement from time to time on notice.
- VI. A GBC2 is required to file a financial statement on an annual basis with the FSC within 6 months after its financial year end.
